Streamlined Sales Tax Project SSTP Kansas SSTP File

Kansas SSTP File Metrics

- ◆ 450,000 Nine Digit Zip Addresses
- ◆ Three files created from this address master
- ◆ Kansas Boundaries Files 100,000 Rows by Block Level Breakout
- ◆ except where SER cuts through nine digit zip code
- ◆ Kansas Nine Digit Zip Code File 30,000
- ◆ Five Digit Zip Code Fall Back Records
- ◆ Total File size for Kansas SSTP is 130,000 rows approx. and it is 20 Meg in size

Kansas SSTP File Creation Lessons Learned

- ◆ Involve the Testing Staff During the Development phases
- ◆ Develop a re-useable Quality Assurance Process for the Data Base
- ◆ Include complete file output examples
- ◆ Regular On-Site Visits in Addition to Weekly Conference Calls
- ◆ Publicity Regarding System Enhancements and Changes
- ◆ Get into a maintenance and update pace Quarterly
 - ◆ 1 month Design
 - ◆ 1 month development
 - ◆ 1month QA and Pre-Implementation Review
 - ◆ post Implementation QA Review utilizing Test Decks

Kansas *SSTP File Creation Lessons Learned*

- ◆ Accuracy Rates will depend on the type of Service (Batch,Online,SSTP)
- ◆ There is a need for access and response control off the SSTP file and other processes (i.e. Transaction code, date and time stamp, metadata)
- ◆ Process Flow and Table Documentation for Third Party Implementers (SSTP) and Testers
 - ◆ WSDL XML Verbiage
 - ◆ Address Decision Tree
 - ◆ SSTP Rates and Boundaries Table Definitions
- ◆ Design and Understand the Error and Transaction Logs
 - ◆ Fall Back Lookups
 - ◆ Address Areas in State with problems
- ◆ Flexible Implementation
 - ◆ Help the user community
 - ◆ Seek guidance for future updates and features

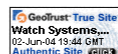
