New York State

- Participated for TY02 and TY03
- Simple approach
 - Letter of invitation
 - Member of Free File Alliance
 - Pass IRS and NYS (PATs) Participant Acceptance Testing System
 - Offer free filing for NYS taxpayers
 - NYS agrees not to compete for one year

New York State TY02 and TY03

- **Program Activity**
 - Approximately 44,000 tax returns filed each year (no growth)
 - Two vendors offered free filing for both Federal and State returns (no growth)

New York State

- **Major Concern and Issues**
 - Lack of growth and vendor participation at the state level
 - 15 vendors – federal participation TY03
 - 3.4 million taxpayers filed federal returns (22% increase over last year)
- **TY02 Feedback**
 - Confusion and frustration by offers that included “free state returns” when the taxpayer paid a fee for the federal return

New York State

- **Goals/Expectations for TY04**
 - NYS expects to offer letter of invitation with our same criteria
 - NYS supports the IRS efforts increase vendor participation
 - NYS strongly encourages vendor to offer both free federal and state filing

Free E-filing for Qualified NYS Taxpayers

New York State taxpayers meeting certain criteria may qualify for free tax preparation and e-filing of their tax year 2003 New York State personal income tax return. Click on a software provider's name to learn more about its offering. Click on the [Start Now!](#) link to connect to their Web site and begin filing your return.

Note: Not every taxpayer qualifies for the free services. Please read carefully the information provided by the company to determine your eligibility and read our [Important information page](#).

Free federal and state tax preparation and e-filing:

TurboTax for the Web: Free federal and state tax preparation and e-filing if you:

- Qualify for the federal [Earned Income Credit](#) (EIC), or
- During calendar year 2003:
 - Were age 62 or older (taxpayer or spouse), or
 - Were age 22 or younger (taxpayer or spouse), or
 - Served active Military duty (including Reservists and National Guard). You must have a 2003 Form W2 from the Military. [Start Now!](#)

TaxSlayer: Free federal and state tax preparation and e-filing if you:

- Are active duty Military personnel, or
- Have [federal adjusted gross income](#) (FAGI) of \$30,000 or less. [Start Now!](#)
